3. Bidders must submit bids for all line items under this bidding process. Fractional Bids shall not be considered and shall be rejected as nonresponsive.

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works, and Non-Consulting Services under IBRD Loans and IDA Credits & Grants dated January 2011 (revised in July 2014) ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

5. Interested eligible bidders may obtain further information and inspect the bidding documents during office hours 10:00 to 17:00 hours at the address given below.

6. A complete set of Bidding Documents in Ukrainian may be received by interested bidders for free subject to submission of a written Application to the address below. Authorized representatives of the Bidders may receive the Bidding Documents at the office of Sub-Project Management Unit at the address below or by method of courier delivery upon condition that this service shall be made payable by the appropriate bidder directly to the providing delivery agents.

7. Minimum qualification requirements, inter alia, shall include the following:

1. At least five (5) years of experience of similar goods production and/or supply (please provide documents evidencing the date of state registration, economic activities according to the National classifier of types of economic activities of Ukraine (KVED) and experience).

2. Successful execution by the Bidder of at least two (2) contracts of similar goods supply with the amount of each of them equivalent to or exceeding 7 250 000 Ukrainian Hryvnia over the period of 5 (five) years.

Qualification of the Bidders submitting bids for several lots will be assessed on a cumulative basis.

8. Bids must be delivered to the address below on or before **15:00** local time on **April 3, 2018**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below.

9. All bids must be accompanied by a Bid Security. The amount and currency of the bid security shall be: 125 000 (one hundred twenty five thousand) Ukrainian Hryvnia.

The Security shall be furnished in the form of an irrevocable Bank Guarantee. All other forms of Guarantee shall not be acceptable to the Purchaser.
